

## **Combined Wedding Package Descriptions**

### **Wedding Package #1 Description - \$2,500 (Two Photographers, 12 hrs.)**

#### **Engagement Photos**

- Up to 3 hours of studio and/or on-location session time.
- One set of 4"x6" hard-copy proofs.
- CD of photographs taken during the session.
- 1 ea. 8"x10" (mounted in a 16"x 20" mat and framed - to be used in lieu of guest book)
- 4 ea. 5"x 7"
- Hair and make-up is the responsibility of the client.

#### **Wedding Day**

- Full day coverage, up to 16 hours. With 2 photographers you get much more coverage since now the photographer can be in two places at the same time.

#### **Slide Show Presentation**

- Clients can provide up to 100 digital photographs or up to 50 hard-copy photographs to be scanned and compiled into a digital slide show that will be shown during the reception. This assumes there is space available for an additional table (4ft.x2ft.), screen (or suitable wall), and available power.

#### **Studio at the reception**

- Studio lighting and backdrops will be brought to the reception and set up (space permitting), in order to provide studio quality portraits for the Bride & Groom, parents, siblings, and guests. This is typically done during or after the reception.

#### **Wedding Album**

- This package includes a 10"x10", 20 page, leather bound, lay-flat album. After you select the photos you want to include in the album, it will be custom designed for you. You will be provided the opportunity to proof the album and have changes made. Up to three revisions will be provided. If you need more than 20 pages, they can be purchased at additional cost

- Slide Show Presentation
- Studio at the Reception
- Up to 12 hours of coverage
- Two Photographer (2<sup>nd</sup> photographer available for 8 hours only)
- Select up to 50 photographs to be touched-up and/or modified.
- 1 set 4x6 hard-copy proofs and proofs on CD media
- 1 ea. 5" x 7" photo for each member of the wedding party (max. 12)
- 1 ea. 8" x 10" photo for parents of the Bride & Groom. (max. 3)
- 3 ea. 8"x 10" photos
- 1 ea. 11" x 14" photo mounted in a 16"x 20" mat.
- 2 ea. 8"x 10" photos mounted in a 11"x 14" mat.
- 4 ea. 5"x 7" photos mounted in an 8"x10" mat.
- 4 ea. 5"x 7" photos
- 1 ea. 10"x10" 20-page, Leather Bound, lay-flat photo album.
- 1 ea. Archival DVD (100 year life span) containing high resolution wedding photos, including the 50 touched-up images previously selected by the client.
- Wedding Album style DVD holder with cameo photo.
- 2 ea. Consumer grade DVDs with the same contents as the archival DVD.
- **15% discount** for additional purchases of prints and/or services off the a-la-carte pricing schedule.

**Final Photograph and Media delivery**

- Within 6 weeks of the reception, the clients will be provided the ability to view the wedding photo proofs in the following ways:
  - via a specified web site
  - through the provided set of hard-copy 4"x6" proofs
  - via a computer CD containing the proofs

## Wedding Package #2 Description - \$1,800 (Two Photographer, 12 hrs.)

### Engagement Photos

- Up to 3 hours of studio and/or on-location session time.
- One set of 4"x6" hard-copy proofs.
- CD of photographs taken during the session.
- **1 ea. 8"x10" (mounted in a 16"x 20" mat and framed. To be used as guest book.)**
- 4 ea. 5"x 7"
- Hair and make-up is the responsibility of the client.

### Wedding Day

- Full day coverage, up to 12 hours.

### Studio at the reception

- Available only if inclement weather prohibits scheduled outdoor photo session.
- Studio lighting and backdrops will be brought to the reception and set up (space permitting), in order to provide studio quality portraits for the Bride & Groom, parents, siblings, and guests. This is typically done during or after the reception.

### ***Clients will be provided:***

- Up to 12 hours of coverage
- Two Photographer (2<sup>nd</sup> photographer available for 8 hours only)
- Select up to 40 photographs to be touched-up and/or modified.
- 1 set 4x6 hard-copy proofs and proofs on CD media
- 1 ea. 5" x 7" photo for each member of the wedding party (max. 12)
- 1 ea. 8" x 10" photo for parents of the Bride & Groom. (max. 3)
- 3 ea. 8"x 10" photos
- 1 ea. 11" x 14" photo mounted in a 16"x 20" mat.
- 2 ea. 8"x 10" photos mounted in a 11"x 14" mat.
- 2 ea. 5"x 7" photos mounted in an 8"x10" mat.
- 2 ea. 5"x 7" photos
- 1 ea. Archival DVD (100 year life span) containing high resolution wedding photos, including the 40 touched-up images previously selected by the client.
- 2 ea. Consumer grade DVDs with the same contents as the archival DVD.
- **\$150 credit** towards the purchase of additional prints or services based on the a-la-carte pricing scale or towards purchase and/or design of a wedding album.
- **15% discount** for additional purchases of prints and/or services off the a-la-carte pricing schedule.

### Final Photograph and Media delivery

- Within 6 weeks of the reception, the clients will be provided the ability to view the wedding photo proofs via a specified web site and/or by being provided one set of hardcopy 4"x6" proofs and a computer CD containing the proofs

## Wedding Package #3 Description - \$1,200 (One Photographer, 10 hrs.)

### What you get:

- Up to 10 hours of coverage, one photographer.
- Proofs on CD media and on-line via a website.
- Select up to 20 photographs to be touched-up and/or modified.
- 1 ea. 5" x 7" photo for each member of the wedding party (max. 10)
- 1 ea. 8" x 10" photo for parents of the Bride & Groom. (max. 2)
- 2 ea. 8" x 10" photos
- 1 ea. 11" x 14" photo
- 4 ea. 5"x 7" photos
- 2 ea. Consumer Grade DVDs containing high resolution wedding photos, including the 30 touched-up images previously selected by the client.
- **\$50 credit** towards the purchase of additional prints or services based on the a-la-carte pricing scale or towards purchase and/or design of a wedding album.
- **10% discount** for additional purchases of prints and/or services off the a-la-carte pricing schedule.

### Final Photograph and Media delivery

- Within 6 weeks of the reception, you will be provided the ability to view the wedding photo proofs via a specified web site and/or by viewing them on the CD that will be provided.

## Wedding Package #4 Description - \$800 (One Photographer, 8 hrs.)

### What you get:

- Up to 8 hours of coverage
- One Photographer
- No hardcopy photographs are available as part of this package.
- Select up to 10 photographs to be touched-up and/or modified.
- Proofs provided via web access, no hard-copy or CD based proofs are provided with this package.
- 2 ea. Consumer Grade DVDs containing high resolution wedding photos, including the 10 touched-up images previously selected by the client.
- **5% discount** for additional purchases of prints and/or services off the a-la-carte pricing schedule.

### Final Media delivery

- Within 6 weeks of the reception, the clients will be provided the ability to view the wedding photo proofs via a specified web site

## Hourly Wedding Description - \$100 / Hr.

Sometimes you don't need 8 hours of coverage, especially if you have a late Friday wedding or a small intimate affair; not a problem, we do plenty of these.

For the most part, the coverage is the same as package #4 but shorter. You still fill out a shoot list to ensure the photos you want are specified and you still get the same quality service.

### ***Clients will be provided:***

- Coverage up to the specified agrees upon timeframe.
- One Photographer (2nd photographer available for \$300)
- Five touched-up photos. Removal of blemishes, bruises, etc.
- **NO** hard-copy photographs are available as part of this package.
- **NO** hard-copy or CD based proofs are provided with this package.
- **NO** discounts towards prints or other services available on the "a la carte" pricing sheet.
- One. Consumer grade DVDs with your wedding photos in two resolutions; (1) small web and email friendly version and (2) larger full resolution images suitable for prints as large as 20"x 30"

### Final Media Delivery

Final DVDs will be delivered within 4 weeks of the reception.

**Note:** For areas outside a 25 mile radius of Rochester NY, a minimum of (3) **three** contracted hours are required. For areas within the 25 mile radius the minimum is one hour.

# “A la Carte” Descriptions and Pricing

## Engagement Photo Session - \$250.00

Clients can select up to 10 poses that will be touched up and color corrected as necessary. This includes conversion to sepia or B&W as well as special effects, such as spot color.

### **Clients will be provided:**

- Up to 3 hours of studio and/or on-location session time.
- 1 set of 4" x 6" hard-copy proofs.
- 1 ea. CD of photographs taken during the session.
- **8"x10" (mounted in a 16"x 20" mat and framed** *(see description below)*
- 4 ea. 5" x 7"
- Hair and make-up is the responsibility of the client.

## 16"x20" Matted and Framed Photograph - \$150.00 *(used in lieu of guest book)*

- A client provided 8"x10" photo will be matted and mounted in a 16"x20" metal frame to be used in lieu of a guest book. Acid Free pens will also be provided. If the source of the photo is an electronic file, or a hard-copy photo that needs to be scanned prior to printing and mounting, a full size proof will be printed and offered to the clients for approval.
- Price includes substitution of client selected wedding photo when available. If wedding photos are taken by a different photographer/studio, the client is responsible for providing an appropriate image in the proper format.

## Bridal Portrait Studio Session - \$350.00 **(\$250 when added to any wedding package)**

This session can include just the Bride and/or family members or members of the bridal party. This session can also be used in lieu of the engagement photo session with the couple being photographed together either before or after the bride gets dressed.

Clients can select up to 10 poses that will be touched up and color corrected as necessary. This includes conversion to sepia, B&W, or special effects, such as spot color.

### **Clients will be provided:**

- 1 – 2 hour studio or on-location session.
- 1 set of 4"x6" hard-copy proofs.
- 1 ea. CD of photographs taken during the session.
- 1 ea. 11"x 14" (mounted in an 16"x 20" mat) can be substituted with 2 ea. 8"x 10's"
- 1 ea. 8"x 10"
- 3 ea. 5"x 7" (2 of them mounted in an 8"x 10" mat)
- Make-up is provided.
- Hair is the responsibility of the client

## **Wedding Day Hourly Rate - \$100/hr.**

Start and end times to be clearly defined in contract. Conditions of, and permission to photograph during the ceremony is the responsibility of the clients.

Photographs not taken during the ceremony, for whatever reason, will be made up immediately after the ceremony and in the same setting. These include staged wedding, posed Bride and Groom, and may include posed family and wedding party group shots.

### **Clients will be provided:**

- 2 ea. Commercial grade DVDs containing high resolution images of photos taken during the contracted time frame.
- Average number of photos range between 50 - 60 / hr.
- 5 images may be selected for touch-up.

Other than the 5 previously mentioned, Images will not be touched up or otherwise altered. No hard-copy proofs or prints will be provided unless purchased separately from the a-la-carte pricing schedule.

## **Second Photographer - \$300 (8 hours)**

For more complete coverage of your ceremony. Also, since a photographer can not be in two places at the same time, it is impossible to photograph both the Bride & Groom getting dressed, especially if travel is required. A single photographer will only shoot the Bride getting ready.

## **Studio at the Reception - \$75**

Studio lighting along with backdrops are brought to the reception for more formal studio type photographs. This is also valuable if the weather chooses not to cooperate for outdoor photos. In order to wedding coverage, this session type is restricted to the Bridal Party and immediate family members.

## **Slide Show Presentation - \$125 (up to 100\*\* client supplied photographs)**

Clients can provide up to 100 digital photographs or up to 50 hard-copy photographs to be scanned and compiled into a digital slide show that will be shown during the reception. This assumes there is space available for an additional table (4ft.x2ft.), screen (or suitable wall), and available power.

## **Proof Set - \$200 ( Wedding Ceremony proof set only.)**

- One set of 4"x6" proofs on glossy photographic paper.

**Note:** Cost of proof sets for packages other than wedding will be determined by the overall number of photographs in the set and may cost significantly less.

## **Photo Touch-ups - \$ 10.00 per image**

- Removal of blemishes, bags under eyes, brighten eyes, whitening teeth, remove stray hair, etc.

## **Special Effects Application - \$ 20.00 per image**

- Includes touch-up as described above.
- Application of spot color, merging images, grunge effects, etc.

## **Archival DVD Media - \$35**

- One additional set of archival (100 year) DVD media. Images are placed on archival quality media with no press-on labels. Labeling is by means of media safe marker. Each DVD is enclosed in a separate hard shell jewel case. This should not be used for every day viewing but for creating duplicate DVDs.

## **Albums - Prices and Styles Vary**

NixImages can provide a number of different style albums from coffee table book to deluxe leather bound, lay-flat books. Since prices can vary greatly all prices for albums will be quoted and billed separately.
